Rules and Regulations.

Purpose

Eligibility and Proof of Eligibility

Open to legal Canadian residents only. Entrants must be 21 years old or older. Only one entry per person allowed (must have valid email address and valid street address — no P.O. Boxes allowed). Multiple entries from any one person will be disqualified. Winners will be required to provide proof of eligibility. No purchase is necessary to enter.

Not Eligible

Deadlines, Winner Selection and Notification to Winners
